MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and executed this ________ day of _______, 2023, by and between:

The DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – CORDILLERA ADMINISTRATIVE REGION, COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE- SABANGAN, with office address at Balaoa, Cabunagan, Tadian, Mountain Province herein represented by its CENR Officer RODEL V. CACPAL and hereinafter referred to as DENR-CAR CENRO-SABANGAN;

-and-

The MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE with office address at Poblacion, Bontoc, Mountain Province herein represented by its SUC President EDGAR G, CUE hereinafter referred to as MPSPC;

The DENR-CAR-CENRO-SABANGAN and the MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE are collectively referred to as "PARTNERS" and individually as "PARTNER".

WITNESSETH

WHEREAS, the DENR is the primary government agency responsible for the conservation, management, development, and proper use of the country's environment and natural resources for the benefit of the present and future generations;

WHEREAS, Executive Order No. 193 series of 2015 expanded the implementation of the National Greening Program (ENGP) and calls for the participation and collaboration of all sectors of society towards natural resources development and management and environmental protection in pursuit of sustainable development and climate change mitigation and adaptation;

WHEREAS, the different National Line Agencies, Local Government Units, Non-Government Organizations, Civil society Organizations and Youth groups positively responded to the call of the government and signified their intentions and committed to collaborate and support the implementation of the Enhanced National Greening Program and actively be involved in the restoration, rehabilitation, maintenance and protection of NGP plantations sites that exhibited low survival of planted seedlings and other degraded forest lands due to forest fires and harsh environmental conditions;

WHEREAS, the DENR- CENRO- SABANGAN, in coordination with MPSPC has identified a Eleven (11.0) hectares NGP plantation located at Catengan, Besao Mountain Province, two (2.0) hectares located at Tue, Tadian Mountain province and two (2.0) hectares located at Guinzadan, Bauko Mountain Province for adoption and designated as the permanent tree planting, growing and nurturing site for the partner agency to rehabilitate and enhance its forest cover;

WHEREAS, the parties acknowledge that environmental protection and enhancement is a shared responsibility of all stakeholders in supporting the vision and aspirations of the DENR towards the sustainable development of the environment and natural resources as well as the attainment of total human development;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree and enter into this MOA under the following terms and conditions:

ARTICLE 1

Roles and Responsibilities of the Parties

A. The DENR - CAR- CENRO - SABANGAN shall:

- 1. Identify and assign potential tree planting sites in coordination with partners;
- 2. Assist the PARTNER in IEC and coordination with LGU and land claimants;
- 3. Provide seedlings for the restoration of the area;
- 4. Provide a map of the plantation site and demarcate on the ground the extent of the area.
- 5. Provide assistance to PARTNERS during the tree planting, growing, nurturing and protection activities;
- 6. Provide technical assistance to PARTNERS in the documentation of activities with the use of geo-tagging devices/drones; and
- 7. Jointly conduct regular monitoring and documentation of the restoration and development of the area.

B. The MOUNTAIN PROVINCE STATE POLYTECHNIC COLLEGE shall:

- 1. Support the implementation of the Enhanced National Greening Program;
- 2. Adopt the Eleven (11.0) hectares NGP plantation located at Catengan, Besao Mountain Province with a site code of 17-144407-0349-0011, two (2.0) hectares located at Tue, Tadian Mountain province and two (2.0) hectares located at Guinzadan, Bauko Mountain Province as permanent tree planting, growing and nurturing area;
- 3. Implement the restoration and development of the area by following the required 4 meters by 5 meters spacing and the maintenance and protection of the same until the area is fully restored and the planted trees fully grown;
- 4. Actively participate in the information drive on fire prevention and conduct fire suppression in coordination with Bureau of Fire Protection; and
- Jointly conduct monitoring and documentation of the restoration, maintenance and development activities and provide copy of documentations to DENR-CAR-CENRO-SABANGAN.

ARTICLE 2

Duration of Memorandum of Agreement

This MOA shall have a term of Five (5) years counted from the date that this instrument is notarized and may be renewed for another five (5) years with the terms and conditions of this agreement and other amendments that maybe agreed by both parties.

ARTICLE 3


Amendments

The MOA may be amended and modified from time to time, in writing and acknowledged by the parties to which amendments or modifications shall be then attached to the original of this instruments.




